In view of the policy statement of DO 62, s. 2011 which states, "Adopt appropriate basic education pedagogy, content, assessment through the integration of Indigenous Knowledge System and Practices (IKSPs) in all subject areas and processes and continuous advocacy".  - Gukum, Gukum Libun, Culture Bearers, Tribal Elders from Lison Valley Ancestral Domain (AD) and Labangan-Suminut-Pagadian City Ancestral Domain (AD-Unified Claim);
 - Members of the IPed Consultative Advisory Body (CAB);
 - Selected IPed stakeholders and partners.
4. Participants are encouraged to wear tribal attire during the assembly.
5. Health and Safety Protocols should be strictly observed such as wearing of face mask, use of alcohol and proper social distancing throughout the duration of the activity.
