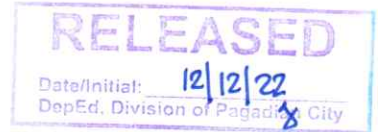

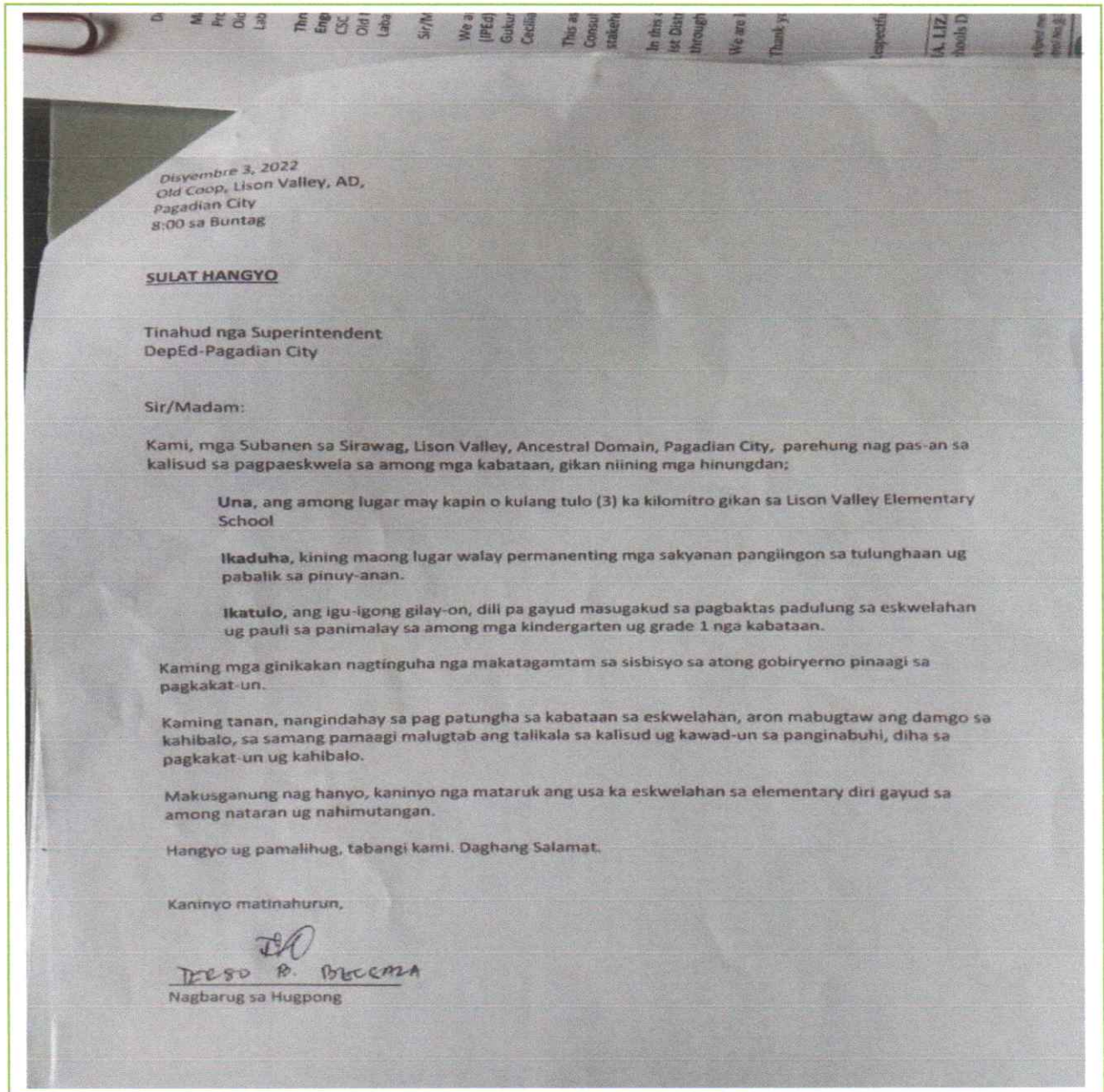

REQUESTING THE DEPARTMENT OF EDUCATION (DepEd) AND OTHER GOVERNMENT AGENCY FOR THE ESTABLISHMENT ELEMENTARY SCHOOL IN SITIO SIRAWAG, LISON VALLEY ANCESTRAL DOMAIN (AD), LISON VALLEY, PAGADIAN CITY

Whereas, Sitio Sirawag is part and parcel of Lison Valley Ancestral Domain (AD), Lison Valley, Pagadian City per Certificate of Ancestral Domain Title (CADT) No. 104-PP4-1106-055. There were Fifty Five (55) Subanen Households with Three Hundred Thirty (330) residents/dwellers occupying in the area.

Whereas, at present, there is no existing elementary school to cater the needs for basic education of the community's school-aged and out of school youth population in the place.

Whereas, this sitio is located approximately four (4) to five (5) kilometers-distant to Lison Valley Elementary School (LVES) and six (6) to seven (7) kilometers-distant to Dumalian Elementary School (DES) more or less, as to its nearest elementary schools managed by the Department of Education (DepEd).

Whereas, there is no regular means of transportation in going to those elementary schools, such as, tricykad, tricycle, jeepney, bus and other form of PUVs were not available. Unstable road network/conditions which often, hamper the free, easy and fast way of travel. "Habal-Habal and Skylab" as alternative way of transport services increased risk of passengers, parents always find them costly, oftentimes, laid down delayed of access during peak hours in going to school and back from school to

- a. Exposure to heavy rain along the way in going school or back to residence, thereby, might be trapped by strong current of water and flood,
- b. Land slide along hill, slopy and road sides,
- c. Falling debris, branches, trunks, stones and boulders during windy/stormy season,
- d. Snake, wild and dog bites,
- e. Caught by darkness along the way home.

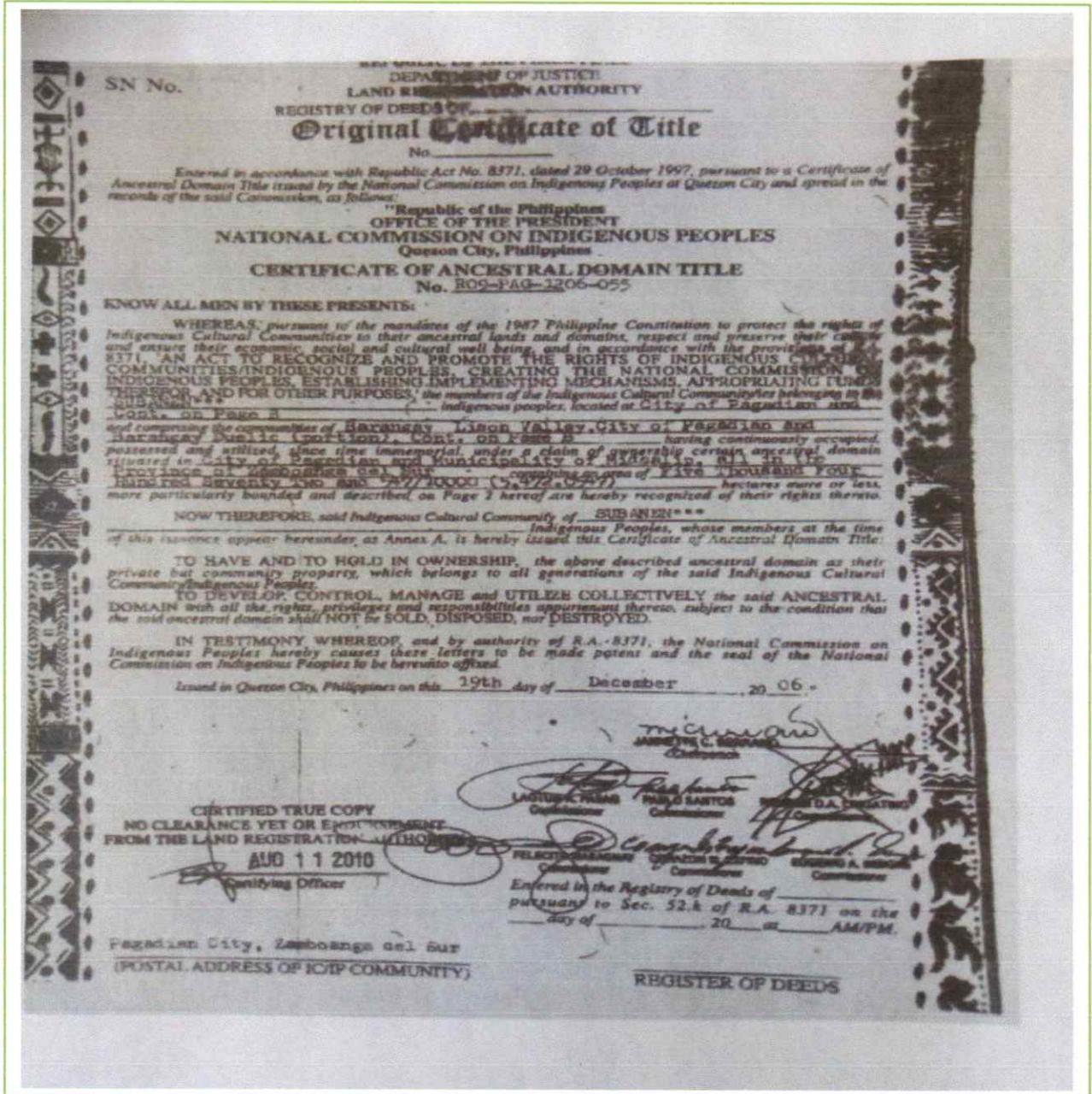

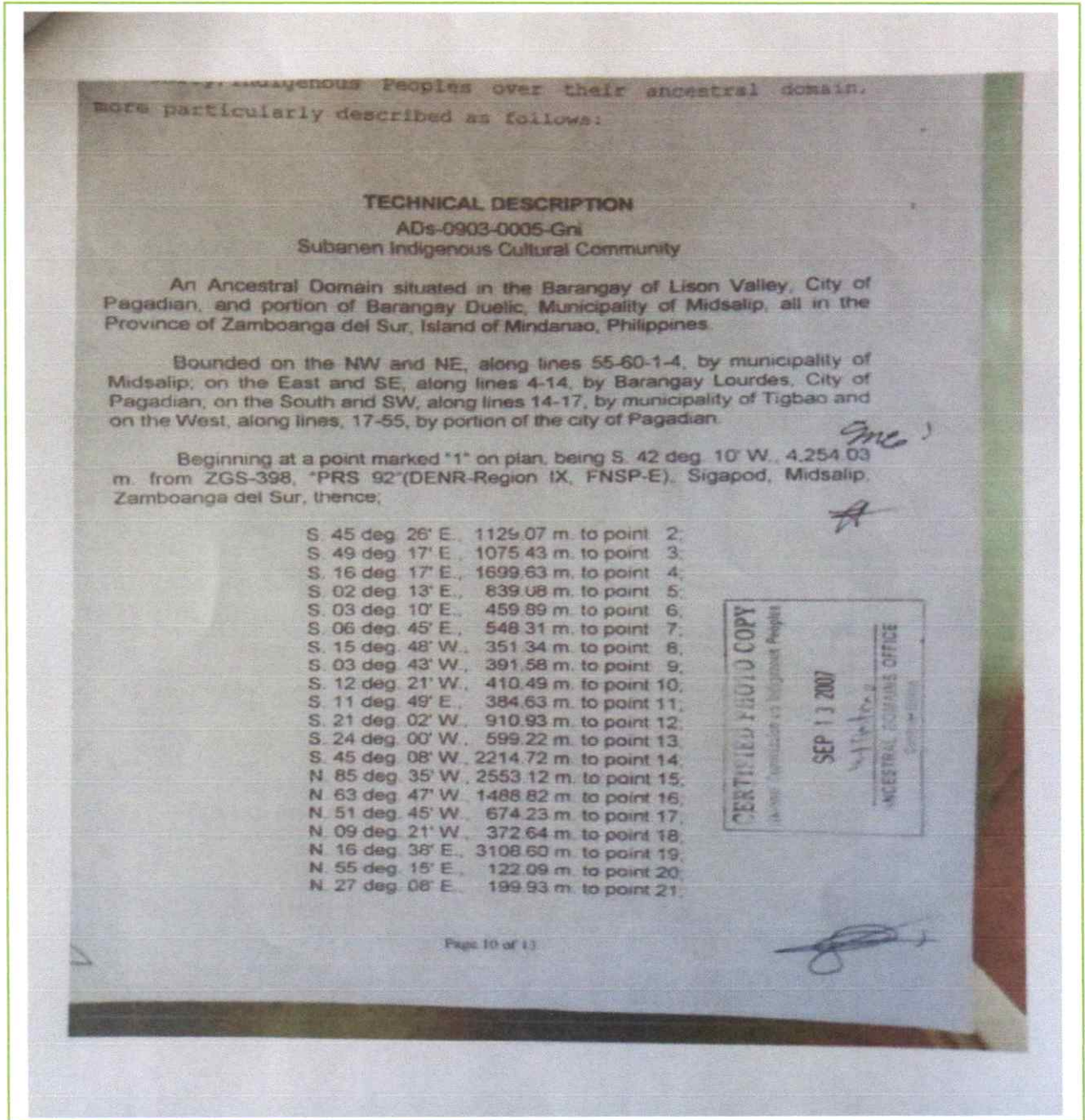

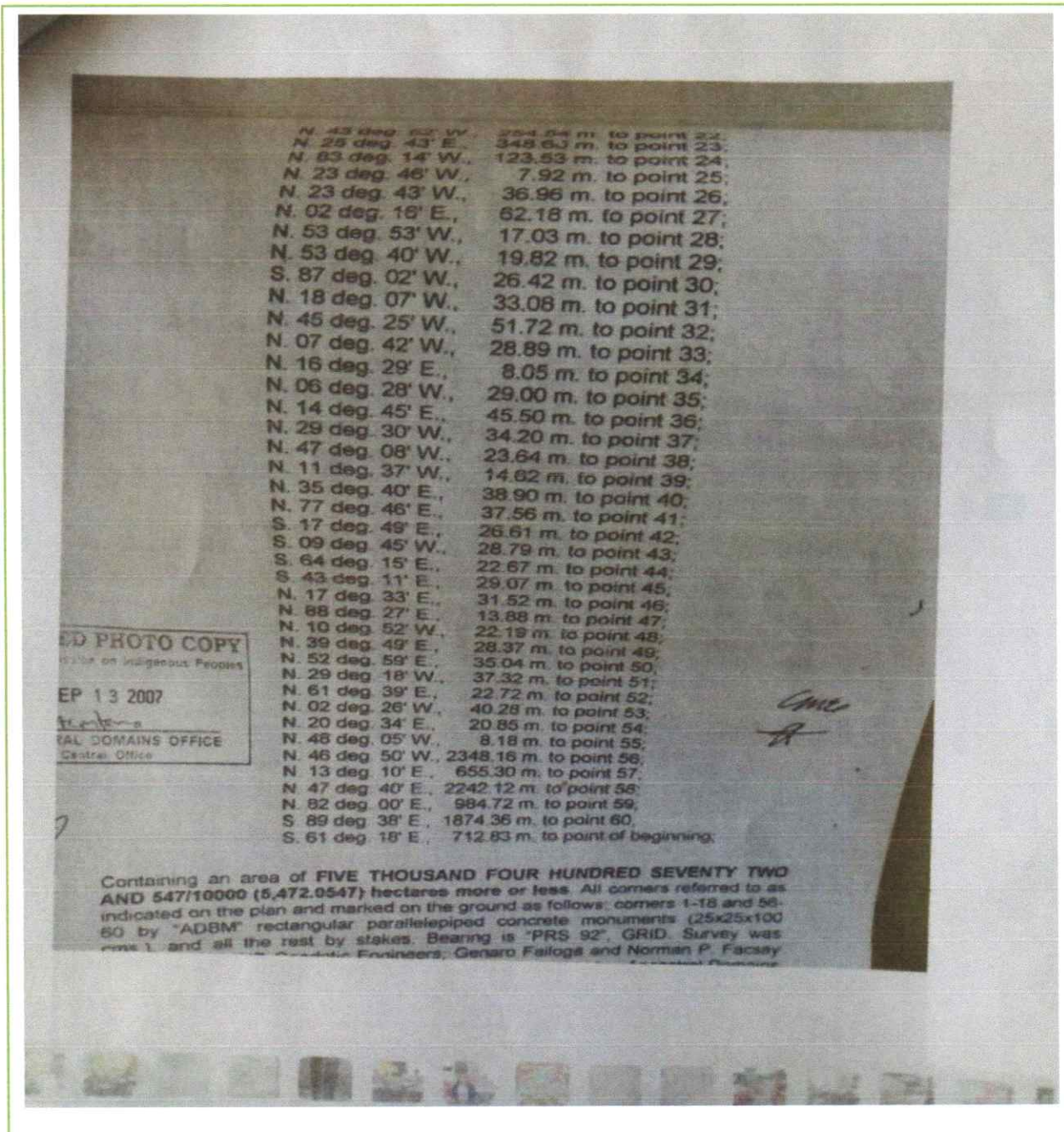
