1. Pursuant to Office of the Undersecretary for Operations (OUOPS) Memorandum No. 2023-03 dated May 5, 2023 jointly signed by Nenneth Esplana-Alama - Director IV, Bureau of Learner Support Services, Dr. Dexter A. Galban, RN, RBP, MBA, MPM - Assistant Secretary for Operations and Atty. Revsee A. Escobedo – Undersecretary for Operations titled *Interim Guidelines of the Learner Government Program (LGP) for School Year 2023-2024* which set forth the proposed/recommended dates, guidelines and procedures on the conduct of school to national Learner Government Program (LGP) elections.

2. That in view thereof, you are all hereby directed to observe, comply and conduct the hereunder activities with the corresponding suggested dates within the prescribed guidelines and mandates in connection with the afore-cited memorandum together with its attachments, to wit:

a. May 22-June 2, 2023	Homeroom Class LGP (SELG/SSLG) Elections
b. June 5-9, 2023	School Based LGP (SELG/SSLG) Elections
c. June 15, 2023	Face-to-Face Division LGP (SELG/SSLG) Elections ( MORNING: 8:00-12:00 AM) - Division Federated <b>Supreme <u>Elementary</u> Learner Government (SELG)</b> Elections

- To be participated by all School **Supreme Elementary Learner Government (SELG)** Presidents.

(AFTERNOON : 1:00-5:00 PM)

- Division Federated **Supreme Secondary Learner Government (SSLG)** Elections
- To be participated by all School **Supreme Secondary Learner Government (SSLG)** Presidents.

d. June 16-July 10, 2023 - Regional Federation LGP (SELG/SSLG) Elections (Venue and specific date to be announced later)

e. August 1, 2023 National Federations LGP (SELG/SSLG) Elections

3. Abovementioned school and division personnel are hereby directed to comply and observe the following:

a. School Head/Principal shall monitor the conduct of Homeroom Class Organization/LGP elections facilitated by the respective class advisers duly supervise by the School LGP (SELG/SSLG) Teacher-Adviser and School Youth Formation Coordinator concerned.

b. School LGP (SELG/SSLG) Teacher-Adviser shall facilitate and conduct the school based federated LGP (SELG/SSLG) elections for the set of officers for school year 2023-2024 with the assistance and supervision of the School Youth Formation Coordinator.

c. School LGP (SELG/SSLG) Teacher-Adviser concerned shall submit the name of each school LGP (SELG/SSLG) federation **president** together with his/her corresponding contact number, active e-mail address and facebook account to **Mr. Richel P. Reducto**, Project Development Officer-1/Division Youth Formation Coordinator on/or before **June 14, 2023** the names of the school LGP (SELG/SSLG) presidents in preparation for Division Federated LGP (SELG/SSLG) elections this coming **June 15, 2023** at Tomas Sagun Elementary School, San Jose District, Pagadian City.

f. Furthermore, all elementary and secondary school heads/principals through their respective school LGP (SELG/SSLG) Teacher-Adviser concerned shall submit to the office of the undersigned through Mr. Richel P. Reducto, Project Development Officer-1/Division Youth Formation Coordinator on/or before **June 30, 2023** a Narrative Report on the conduct of elections with the corresponding list of school LGP (SELG/SSLG) set of officers for School Year 2023-2024.

4. Pursuant to the recently issued and aforementioned OUOPS Memorandum No. 2023-03 pertaining to the conduct of LGP (SELG/SSLG) elections for school year 2023-2024, the undersigned hereby directs Mr. Richel P. Reducto, Project Development Officer-1/Division Youth Formation Coordinator to conduct monitoring on school LGP (SELG/SSLG) elections.
