

ANNOUNCEMENT OF QUALIFIED ATHLETES, COACHES, ASST. COACHES, CHAPERONS, TRAINERS, DELEGATION OFFICIALS AND OFFICIATING OFFICIALS TO THE 2023 ZAMBOANGA PENINSULA REGIONAL ATHLETIC ASSOCIATION (ZPRAA) MEET

- 1. The Zamboanga Peninsula Regional Athletic Association (ZPRAA) Meet 2023 will be held on **April 24 28, 2023**. The activity will be hosted by the Local Government Unit of Zamboanga del Sur and co-hosted by DepEd, Pagadian City Division.
- 2. Enclosed is the **list of qualified Athletes, Coaches, Asst. Coaches, Chaperons, Trainers, Officiating Officials, Delegation Officials to the Regional Meet** and carefully selected and recommended by sports specialist assigned as Tournament Managers during the conduct of the 2023 Pagadian City Division Athletic Association (PCDAA) Meet.
- 3. A **7 Days** ZPRAAM MEET shall commence on **April 22- 28**, **2023** at Balangasan Central School as billeting quarter of Pagadian City Delegation.
  - 3.1. All qualified athletes must engage in actual practice/training with their respective Coaches, Asst. Coaches, Chaperons and Trainers.
  - 3.2. All coaches are expected to submit **PROGRESS REPORT** of the training to the asst. training directors assign in the event after 5 days of the school base training.
  - 3.3. All Athletes must be given consideration by their respective class adviser/teachers of this division during their training/practice up to the 2023 ZPRAA Meet.
  - 3.4. The following personnel shall provide technical support to their respective assigned sports—event or team during the training: overall training Director, training directors (Elem/Sec.), Asst. training directors head coach (Elem. & Sec.).
- 4. Athletes who will not meet the requirements, such as: discipline, attendance during the training/practice and Regional Qualifying Standards during the tune ups and time trials set for this purpose will be dropped from the master list. No replacement shall be made.
- 5. School administration of individual and winning teams are requested to provide for the Initial training preparation of athletes/team through local sources/sponsors and school MOOE.
- 6. All teams will report on **April 22**, **2023 Saturday 8 a.m.** in their respective billeting rooms in Balangasan Central school with the following:

- a. Complete documents for screening
- b. Beddings 1 bed sheets, pillow, mosquito net
- c. Eating paraphemalia/kitchen utensils
  - Plate/tray
  - Spoon and glass
  - Drinking glass
  - Cup
- d. Toiletries
  - Bath soap
  - Towel
  - Tooth brush/tooth paste

"Failure to report on April 22, 2023 will be a reason for exclusion in the list".

- 7. Transportation of athletes, coaches and chaperons in going to Balangasan Central School will be borne by their respective schools.
- 8. All technical officials are expected to be at the venue on April 22, 2023 and present your Authority to travel and Latest Medical Certificate duly signed by Medical Officer with impressions as **PHYSICALLY FIT**. (Football Technical Officials will have their advance games on April 23, 2023.
- 9. Members of Division screening and records committee will report on April 17, 2023 at ZSSAT to start the final rechecking the completeness of athletes documents and other Pertinent requirement of Coaches and other concerned are expected to complete all the needed requirements on or before the deadline of the RSAC.
- 10. Service credit shall be given to officiating officials, coaches, chaperons for service rendered on Saturday and Sunday. Likewise, all DepEd Officials, Division Sports Officers/Coordinators and staff May avail the Compensatory Time-Off credits. Referred to Regional memo no. 103, s. 2023
