3. That school principal, Crestina T. Parot is hereby requested to allow the above-named registered guidance counselor to conduct the afore-cited requested counseling activity/program on official business.

That above-named registered guidance counselor is advised to coordinate with the guardian of the learner-victim, Dulce Amor Arambala-Galvez of Santo Niño Elementary School, Santo Niño District, Pagadian City as to the scheduling of the said intervention and counseling activity and further directed to submit reports on the intervention and counseling services undertaken to the division Learner Rights and Protection Office focal, Mr. Richel P. Reducto – Project Development Officer – 1, School Governance Operations Division (SGOD) of this division.

5. Please be guided by DepEd Order No. 40, Series of 2012, DepEd Order No. 55, Series of 2013 and other laws, rules and regulations and issuances by the Department of Education in the performance of your duties.
