



- 2. Correspondingly, all school heads are hereby requested to submit the composition of their School GAD Focal Point System for School Year 2025-2026 using the attached template
- 3. The function of the GAD Focal Point System (GFPS) are as follows:
  - a. Lead in the gender mainstreaming of the policies, plan, projects and activities (PPAs) as well as the assessment of gender-responsiveness of systems, structures, policies, procedures and programs based on priority thrusts, needs and concerns of DepEd stakeholders particularly students/pupils. Teachers and employees.
  - b. Analyze programs and projects using the harmonized GAD Guidelines for Programs and Projects to determine their gender sensitivity.
  - c. Recommend formulation/revision of policies in advancing women's status and child protection;
  - d. Lead in then view and updating of sex-disaggregated data for GAD database to serve as basis in performance-based gender responsive planning;
  - e. Implement advocacy activities, including the development of information, education, and communication materials to ensure consciousness-building and support for GAD;
  - f. Identify gender issue arising from gender analysis and audit to serve as basis for determining PPAs in the GAD plan;
  - g. Prepare GAD plans, budgets, and accomplishment reports for prompt submission to concerned offices;
  - h. Ensure the effective and efficient implementation of the GAD plan and PPAs as well as the judicious implementation of then GAD budget and;
  - Build and strengthen partnership with all GAD Focal Point Persons in DepEd Philippines Commission on Women (PCW), Local Government Units, GAD, relation Non-Government Organizations, and other partners.
- 4. The task and function of the member of the Division and School Level GFPS shall be part of their regular Key Result Areas (KRAs) work plans, and performance assessment indicators.
- 5. Immediate dissemination of and strict compliance with this Memoorandum is directed.
