

- 3. The following shall be the duties and responsibilities of the Task Force:
  - a. Coordinate with local law enforcement and barangay officials to ensure preventive security measures.
  - b. Monitor, document, and submit an incident report regarding the situation before, during, and after April 27, 2025.
  - c. Advise and guide school administration on lawful procedures to protect school property.
  - d. Maintain communication with the Schools Division Superintendent and Assistant Schools Division Superintendent for timely updates.
  - e. Ensure that the safety of learners and personnel remains the top priority.
- 4. The Task Force is directed to operate within the bounds of applicable laws and DepEd policies, and to conduct itself with utmost professionalism and discretion.
- 5. Immediate and strict compliance with this memorandum is hereby directed.
