**ADDENDUM OF THE 2-DAY TRAINING ON FOUNDATIONAL COURSE ON ADOLESCENT
REPRODUCTIVE HEALTH**

To: Secondary and Elementary School Heads

1. The "foundational course on adolescent health" would likely be a training document detailing the key aspects of adolescent health, including physical, mental, and social development during this life stage, common health concerns, risk factors, preventive strategies, and appropriate communication methods for working with adolescents; often used by healthcare professionals, educators, and community workers involved in adolescent health programs.
2. The ARH Education is in support of DepEd's commitment under R.A. 10354 or the Responsible Parenthood and Reproductive Health Act of 2012, which mandates the institution to deliver a sustainable and age- and development-appropriate reproductive health education and training for educators to create an inclusive and integrated Responsible Parenthood and Reproductive Health Education in formal, informal, and indigenous learning
3. The objectives of this training workshop are the following:
 - a. To equip our Guidance Counselors and Guidance Advocates about HEEADSS;
 - b. Understanding adolescent development:
explain the physical, cognitive, emotional, and social changes adolescents experience during this developmental period.
 - c. Identifying common health concerns:
recognize prevalent health issues among adolescents such as nutrition, sexual and reproductive health, mental health, substance abuse, and injury prevention.
 - d. Promoting healthy behaviors:
To educate adolescents on healthy lifestyle choices including nutrition, physical activity, sleep hygiene, and stress management.
 - e. Addressing sensitive topics:
To discuss sensitive topics like sexuality, contraception, and sexually transmitted infections with adolescents in a respectful and informative manner.
 - f. Recognizing warning signs:
To identify potential signs of mental health issues, substance abuse, or other concerning behaviors in adolescents.
