



- 2. The DPSSC is in-charge of the district selection process for higher teaching positions per DO 20 s 2024.
- 3. There shall only be five (5) DPSSCs in the elementary namely: East, West, North, South and Central districts and two (2) in the secondary: Cluster 1 and Cluster 2.
- 4. The DPSSC of the secondary level shall be created per learning area/specialization for Junior High School (JHS) and Senior High School (SHS). The PSDSs assigned in the two (2) clusters shall be responsible for the over-all organization

- 5. of the sub-groups per learning area including its operational concerns. The Education Program Supervisors (EPSs) of every learning area shall act as co-lead and shall take the responsibility of the assessment and evaluation of applicants per learning area.
- 6. It shall also assist the HRMPSB in the comparative assessment process. Since the sub-committees shall only serve as an assistorial body, the HRMPSB shall maintain full responsibility and accountability of the comparative assessment results, and therefore, shall be responsible in responding to queries and complaints pertaining to the comparative assessment.
- 7. Annex A contains the list of DPSSC members of both elementary and secondary levels.
- 8. Division Memorandum No. 29 series of 2024 (Sub committees for the Selection of Teacher II and Teacher III Positions) is hereby rescinded, repealed or amended accordingly.
- 9. Widest dissemination and immediate compliance to this memorandum is enjoined.
