- 1. Regional Memorandum No. 596, s. 2024, titled Conduct of Regional Orthography Development signed by RD Ruth L. Fuentes, CESO III issued last September 23, 2024, states that the Department of Education needs to develop proficiency in Filipino and English, and that the first three years of elementary education, instruction, teaching materials, and assessment shall be in the regional or native language of the learners. In this regard DepEd Region IX through CLMD will conduct a five-Day Workshop on the development of standardized orthography for the Subanen and Sama Bangihngih languages this coming February 16 - 21, 2025, at Hotel Guillermo, Pagadian City.
- 2. In consonance with the aforementioned memorandum, Pagadian City Division announces its participation in the Conduct of Regional Orthography Development that is vital for ensuring consistency in written materials, enhancing educational practices, and supporting the cultural identity of our IP learners.
- 3. This activity aims to:
 - a. Brings together linguists, educators, community elders, and cultural experts across the region; and
 - b. Engage collaborative sessions to explore linguistic principles, cultural considerations, and practical application.
