



 - b. Duly accomplished PDS (CSC Form No. 212, Revised 2017) with Work Experience Sheet;
 - c. Photocopy of Voter's ID and/or any proof of residency;
 - d. Photocopy of valid and updated PRC License/ID;
 - e. Photocopy of Certificate of Board Rating;
 - f. Photocopy of scholastic/academic record (i.e., Transcript of Records (TOR) and Diploma, including completion of graduate and post-graduate units / degrees, if applicable;

- Photocopy of certificate/s of relevant specialized trainings or professional development programs, if any:
- i. Photocopy of valid Technical Education and Skills Development Authority (TESDA) National Certificate (NC) II, Trainers Methodology Certificate (TMC), if applicable;
- k. Photocopy of the required Performance Ratings with at least Very Satisfactory rating. (Note: The applicant shall submit at most three (3) performance ratings depending on the performance requirements per item 25 of DO 20, 2024. The latest performance rating shall cover one (1) year complete performance rating period in the current position:
- Checklist of Requirements and Omnibus Sworn Statement on the Certification on the Authenticity and Veracity (CAV) of the documents submitted and Data Privacy Consent Form pursuant to RA No. 10173 (Data Privacy Act of 2012), using the attached form (Annex C), sworn before a public officer authorized to administer oaths pursuant to Section 41 of EO No. 292, as amended by RA No. 6733 and as further amended by RA No. 10755; and
- m. Other documents as may be required by the HRMPSB, including but not limited to portfolio for the assessment of identified PPST non-classroom observable indicators.
- Individuals who failed to submit complete mandatory documents (items A to L) on the set deadline indicated in the official memorandum shall not be included in the pool of official applicants.
- 5. Late submission of applications and lack of documentary requirements after the deadline will not be entertained by this Office.
